M/s. State Life Insurance Corporation of Pakistan submitted the technical proposal and accompanying documents for the evaluation of eligibility and technical criteria. Among the requisite documents, they also provided an exclusion aimed at excluding specific benefits that conflict with the Group Health benefit prerequisites given by the Sindh Education Foundation, as detailed in the tender's technical requirements as mentioned in the TORs technical requirements of the tender. However, the SEF has concluded that the Exclusion document (Annex-I), submitted by M/s. State Life Insurance Corporation of Pakistan completely contradicts the TORs outlined in the Group Health Insurance Policy of SEF, which is deemed UNACCEPTABLE by the SEF. Therefore, the submitted bid of M/s. State life is found in the CONDITIONAL BID which has contradictions with the requirements of SEF as specified in the bidding document and the bid shall be treated as REJECTED and O.T. from the bid evaluation process in compliance of SPP RULE 2010 amended latest.			
M/s. United Insurance Company has failed to qualify the requirements of eligibility criteria No. 2 & 3. Hence has been disqualified. M/s. Adamjee Insurance Company has been found qualified in accordance of SPP RULE 2010 amended latest and recommended by the Procurement Committee for further procurement process.
